PERM5 is in partnership between [ESPP](#) and [BioRefine Cluster Europe](#)

PERM4, June 2021, brought together 370 participants online (see summary in [SCOPE Newsletter n°141](#)). PERM5 will follow on from the 4<sup>th</sup> European Sustainable Phosphorus Conference in Vienna and online (hybrid) with an expected 250 – 300 participants in Vienna plus as many online.

There is no fee to submit abstracts. The abstract format is the same for oral presentations and for posters. Abstracts submitted for ESPC4 in 2021 and not selected will be automatically forwarded and considered for PERM5.

1) Presentations for parallel sessions (10 minutes)

PERM5 will include 2 sets of 3 parallel sessions (one set in the morning, one in the afternoon) on:

- Iron and phosphate interactions in P-recovery and in agronomy
- Nutrient recovery from dairy industry processing
- Other R&D themes depending on abstracts received, probably including:
  - From research to implementation: studies or experience of how to convert research results and recommendations into user uptake or policy changes
  - New fertilisers and biostimulants to improve crop nutrient uptake
  - Farm-to-Fork Zero Pollution: reducing P losses from agriculture
  - Greenhouse emissions and LCA for nutrient recycling processes
  - Nature based solutions for nutrient abatement
  - Nutrient recycling through decentralised sanitation / separative urine systems
  - Nutrient flow studies for cities, regions, countries
  - other to be defined as a function of abstracts received

2) Posters

Can be on any theme relating to phosphorus and nutrient sustainability, management or recycling.

Posters will be displayed both at ESPC4 (if an author is present) and at PERM5 and will be published via the onsite/online networking app for all ESPC4 and PERM5 registrants, and in the online conference proceedings.

**Abstracts should be sent by 27/2/2022 to [info@phosphorusplatform.eu](mailto:info@phosphorusplatform.eu) in the following format:**

In WORD or RTF (not PDF), 1- page (maximum) including (in this order, in English):

- Title – max 15 words
- Summary of content – max 200 words
- Authors:
  - Name of lead author  
(‘NAME Givenname’, that is: NAME in capitals, Given Name not in capitals – e.g. “SMITH John”)
  - Job title/position, organisation, country and email (obligatory) for lead author
  - Name, position, organisation, country and email (obligatory) for other authors
- OPTIONAL: short list of key reference publications, websites or other sources of background and supplementary information (maximum = 6 items)

Diagrams and photos can be included, subject to the abstract not exceeding one page in WORD.
